In signing the foregoing release, I hereby acknowledge and represent, that I have read the foregoing release, understand it and agree to it voluntarily, that I am 18 years of age or older, and of sound mind, or will be 14, 15, 16, 17 or 18 years of age prior to December 31 of this year and I have co-signed with a parent or guardian, as the case may be. Proof of age may be required.
